ELECTION**

SECTION 1.

- (a) The election of officers shall be held at the second meeting in the months of May and November. Bethels under Supreme and Grand may hold election at another time by amendment to their Bylaws. (See SI 14.18)
- (b) The election shall be by ballot without nomination. A majority vote, one more than half, ignoring blanks shall elect.
- (c) The method of balloting shall be by secret ballot.
 - (1) Each active member, upon signing the permanent record book, shall have the right to cast her secret ballot in any Bethel election. The sole exception shall be members who are under suspension. No additional requirements shall be imposed.
- (d) and (e) See Page C-Bethel 2.
- (g) Election shall be from members present, except in case of sickness or other unavoidable absence. The Executive members of the Bethel Guardian Council present shall decide upon and announce the eligibility of the absentee.
- (h) All officers shall be entitled to vote until the end of the term even though they become twenty (20) years of age before the next election.
