



## Missouri Job's Daughters HIKE License Plate Program

Job's Daughter HIKE license plates are special personalized plates, approved by the MO DOR in 2002, which use the official emblem of The Hearing Impaired Kids Endowment Fund, Inc. (The HIKE Fund, Inc.). A contribution to The HIKE Fund, Inc. of \$25 per year (\$50 if two-year) as well as the personalized plate fee of \$15 per year (\$30 if two-year) is required.



To get a HIKE LICENSE PLATE follow these steps:

1. Complete this form and send it to the Missouri JDI Grand Secretary at the address below with your contribution to The HIKE Fund, Inc. of \$25 for one year or \$50 for two years.
2. The Grand Secretary will send you an "Emblem Use Authorization Statement."
3. If this is a new HIKE plate application, an "Application for Missouri Personalized and Special License Plates" DOR Form 1716 will also be sent. Select up to a six character personalized plate message. (Four characters for a disabled plate). All HIKE license plates are considered personalized plates and require payment of a \$15 one-year personalized fee, or \$30 two-year fee to the Department of Revenue.
4. Take your "Emblem Use Authorization Statement" and the personalized plate fee to your local license office as well as your renewal notice and other papers from the Department of Revenue with you. If you choose a biennial registration, your "Emblem Use Authorization Statement" must show a \$50 contribution to The HIKE fund, Inc.
5. If this is a new HIKE plate application, also take your "Application for Missouri Personalized and Special License Plates," to your local license office OR send to Motor Vehicle Bureau, P.O. Box 100, Jefferson City, MO 65105-0100. The Department of Revenue will order your plates and notify you when your plates are available at your local license bureau. If you have any questions about processing of your "Application for Missouri Personalized and Special License Plates," direct them to the Department of Revenue through your local license bureau.
